Request

(This is a follow up to FOI DoF/2023-0056)

Please could you answer all the same questions in the same format as previously asked in the FOI attached.

- 1. The total amount of covid deaths?
- 2. The total amount of covid deaths with at least one other condition mentioned on the death certificate?
- 3. The total amount of covid deaths with only covid mentioned on the death certificate?

All three questions to be answered in total amounts and then broken down by age groups please.

Response

I can confirm that the Department holds the information requested.

Of the **5,391** Covid-19 related deaths that had occurred up to 8 September 2023 (accounting for registrations up to and including 13 September 2023), **273** had Covid-19 as the **only** cause of death mentioned on the death certificate. The remaining **5,118** covid-19 related deaths had <u>at least one</u> other cause of death mentioned on the death certificate.

The tables below provide the information requested.

To select relevant cases for Covid-only deaths (those without other causes of death recorded), NISRA included deaths which mentioned only Covid-19, with or without pneumonia, in Part 1 of the death certificate. Pneumonia was included, as early discussions with the Department of Health indicated that certifying doctors may have made no distinction between Covid-19 and Covid-19 pneumonia. Also excluded are deaths where Covid-19 led to another condition, which in turn led to death.
